1. 840 Shares owned outright.
2. 116,543 Restricted Stock Units (RSUs) granted on May 13, 2026, which will convert into an equivalent number of shares of Conduent Incorporated's common stock (Common Stock) upon vesting, that vest in equal 1/3 installments on December 31, 2026, December 31, 2027 and December 31, 2028;
3. 58,270 Performance Restricted Stock Units Share Price Hurdle (2026 PRSU-Share Hurdle awards); Award of performance restricted stock units that can only be settled in Common Stock. The 2026 PRSU-Share Hurdle award will cliff vest on December 31, 2028, subject to Conduent Incorporated's Common Stock meeting an average closing stock price over any 120 consecutive calendar day period during the measurement period of April 1, 2026 through December 31, 2028 (the "average closing price") of at least \$2.50 per share. If an average closing price of \$2.50/share is achieved, 25% is eligible to vest; if an average closing price of \$3.00/share is achieved, 50% is eligible to vest; if an average closing price of \$4.00/share is achieved, 75% is eligible to vest, and if an average closing price of \$5.00/share or greater is achieved, 100% is eligible to vest, with linear interpolation between stock prices.

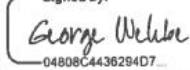
